LAND PROTECTION HIGHLIGHTS

- PCT and PCT experience)
- Forest Service purchased three land parcels, totaling 60 acres, at Agua Dulce, Calif.
- Forest Service purchased two land parcels, totaling 1,090 acres, from Plum Creek Timber in Wash.
- \$1.575 million secured for PCT from Land Water Conservation Fund
- PCTA Land Protection Committee completed a land acquisition plan
- Conservation easement purchased for Keene Creek property, permanently protecting 1 mile of the PCT in southern Ore.
- Continued work with Tejon Ranch Corp. and Forest Service: to refine 35-mile trail route, to design protective corridor for PCT, and to specify terms of an easement to protect PCT experience
- Tejon Ranch announced 240,000-acre conservation plan and formed Tejon Ranch Conservancy

TRAIL MAINTENANCE & RECONSTRUCTION ACCOMPLISHMENTS

- PCTA coordinated 62,537 hours of volunteer trail maintenance in 2008
- 66,946 trail maintenance volunteer hours logged on the PCT last year (valued at \$1,306,000)
- 40% of PCTA volunteer trail maintenance hours derived from youth and young adult trail programs
- Since 2004 the PCTA has more than doubled the size of its volunteer trail work program (from 27,284 hours to 62,537 hours)
- 27 volunteers donated more than 300 hours; 14 volunteers donated more than 500 hours
