



## ORDER 18-2014-04-06

## EMERGENCY CLOSURE FOR PUBLIC HEALTH AND SAFETY

WILLAMETTE NATIONAL FOREST  
Detroit Ranger District

Pursuant to 36 CFR 261.50 (a) and (b), the following acts are prohibited in the area, and on roads and trails described in this order within the Willamette National Forest. This order will become effective upon signature, and will remain in effect until rescinded.

Pursuant to Title 36 CFR §261.50(e), the following persons are exempt from this Order:

- (1) Any person with a permit specifically authorizing the otherwise prohibited act or omission.
- (2) Any Federal, State, or local official or member of an organized rescue or firefighting force in the performance of an official duty.

**DESCRIPTION OF AREA:**

The order applies to the area contained within the boundaries as described within the Mt. Jefferson Wilderness, Linn County:

- Beginning at the Mt. Jefferson Wilderness boundary intersecting with Pamela Lake Trail #3439, head north to Milk Creek;
- Follow Milk Creek east to the Pacific Crest Trail #2000;
- Follow the Pacific Crest Trail #2000 south to the Swallow Lake Trail #3488;
- Follow the Swallow Lake Trail #3488 west to the Lake of the Woods Trail #3493;
- Follow Lake of the Woods Trail #3493 north to Whiskey Creek;
- Follow Whiskey Creek west to Puzzle Creek;
- Follow Puzzle Creek west to the Mt. Jefferson Wilderness Boundary;
- Follow the Mt. Jefferson Wilderness boundary north to the point of beginning.



- Lake of the Woods Tr. #3493 north of the Swallow Lake Tr. #3488 junction

**Trails still open within closure area include:**

- Pacific Crest Trail #2000
- Swallow Lake Tr. #3488 west of the junction of Lake of the Woods Tr. #3493
- Lake of the Woods Tr. #3488 south of the junction with Swallow Lake Tr. #3488.
