



**Forest Order No. 05-12-00-23-03**  
**San Bernardino National Forest**  
**Forest Roads Closure**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(b), and to provide for public safety and protect natural resources, the following act is prohibited within the San Bernardino National Forest. This Order is effective from **March 18, 2023**, through **June 30, 2023**.

Operating a motor vehicle on any National Forest System Road within the Mountaintop Ranger District, or on any National Forest System Road within the Front Country or San Jacinto Ranger Districts that is listed in Exhibit A.

Motor vehicle means any vehicle which is self-propelled, other than (a) a vehicle operated on rails; and (b) any wheelchair or mobility device, including one that is battery-powered, that is designed solely for use by a mobility-impaired person for locomotion and that is suitable for use in an indoor pedestrian area.

**36 C.F.R. § 261.54(a).**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with a Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order;
2. Any Federal, State, or local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty;

These prohibitions are in addition to the general prohibitions contained in 36 C.F.R. Part 261, Subpart A. A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.
